



# EXHIBITOR RULES

**August 26 & 27, 2022**

EXHIBITOR hereby contracts with the Win on the Wabash (WoW) Committee for space at the WoW Super Raffle.

1. EXHIBITOR agrees to use and pay for the booth space as described. EXHIBITOR agrees to accept space assigned and will not sub-let to anyone else.
2. When ACTS OF GOD or any other causes not within the control of the WOW Committee and all affiliated Directors, Officers, Members, staff, employees, volunteers, sponsors, and persons or organizations make it impossible for the vendor to occupy the Festival premises, then in such case the WOW Committee and all affiliated Directors, Officers, Members, staff, employees, volunteers, sponsors, and persons or organizations are jointly released from any and all claims for damages which may arise as a consequence thereof.
3. The EXHIBITOR also agrees to the following conditions of this contract.
  - a. Set up shall be completed by 12:00 Noon on Friday August 26, 2022. All vehicles must leave the show area at this time as well.
  - b. Only merchandise specified in contract may be sold. No side raffles are allowed unless free.
  - c. Booth sharing by EXHIBITORS is not permitted.
  - d. The EXHIBITOR agrees to use qualified labor at all times.
  - e. The management shall be entitled to close an exhibit at any time for failure of EXHIBITOR to perform, observe and comply with any term set forth in the contract.
  - f. EXHIBITOR shall not be entitled to a refund or any part of any fee should he/she, for any reason, is unable to participate after acceptance.
  - g. If for any reason the management determines that the location of the Exhibitors should be changed or dates should be changed, management reserves this right.
  - h. All Pertinent laws, ordinances and regulations pertaining to health and public safety shall be strictly observed.
  - i. EXHIBITORS shall have appropriate insurance.
  - j. EXHIBITOR will cooperate by keeping area clean.
  - k. Exhibits left over-night are at the EXHIBITORS own risk.
  - l. The number of exhibitors will be limited by their merchandise. Interested parties will be reviewed as received and accepted or rejected on first come first served basis.

The WOW Committee and all affiliated Directors, Officers, Members, staff, employees, volunteers, sponsors, and persons or organizations are not responsible for accidents and will not assume liability for any injuries, damages, losses, or otherwise that may arise, result from, or occur in relation to an Exhibitor's operation of an Exhibitor's Booth. This shall include, without limitation, liability for any claim of bodily injury, death, property damage, or of any loss or damage whatsoever. All Exhibitors acknowledge and assume full responsibility and liability for any injuries, damages, losses or liability that may arise, result from, or occur in relation to their operation of an Exhibitor's Booth.
